This letter is to inform you as an adjoining property owner that the Hernando County Board of County Commissioners (BOCC) has received a petition from **Joshua Boyle within Royal Highlands plated subdivision**. The petitioner is seeking this vacation for the **removal of the inner Easement** to build a home. A copy of the petitioners' survey is enclosed.
