- How close can an airboat operate to a residence?
  - Sec. 7-73. - Operation of vessels, watercraft and airboats; prohibited conduct.
    - (c) Airboats are to remain at least one thousand (1,000) feet from any dwelling while in operation. This shall not include airboats leaving or returning to a port, ramp or residence, or airboats operating within a marked channel or seaward of a marked channel.

- Jenkins Creek Spring Run project – FWC has a consultant collecting data in the area and will identify activities needed for project.
- Manatee Protection Zone (MPZ) – BOCC proposed changes; requested sending survey to all residents living on the Mudd River and associated tributaries.
- Weeki Wachee River plantings – Five months post installation (83% survival); king tide did effect plantings close to Roger's Park. Consultants will be replanting in this area.
