#### **TITLE**

Change Order No. 1 to Purchase Order With Centrisys CNP Corporation for Repair of Centrifuge Equipment for Utilities Department (Contract No. 25-TS0204/JC; Amount \$367,550.00)

#### **BRIEF OVERVIEW**

On March 11, 2025, the BOCC approved award of Contract No. 25-TS0204/JC to Centrisys CNP Corporation a/k/a Centrifuge-Systems, LLC d/b/a Centrisys for the repair of Centrifuge #3 for \$218,000.00.

The purchase order was originally issued for \$218,000.00. Change order No. 1 in the amount of \$367,550.00, would increase the purchase order to \$585,550.00.

Hernando County Utilities Department has requested an increase for Purchase Order No. 1 to add the repairs of Centrifuge #1 to the current purchase order.
