### APPROVAL OF MINUTES – postponed until July 14, 2025

### MARINE PATROL REPORT

- Florida Freedom Boating Act - changes how HCSO conducts business. Law enforcement can no longer stop or board a vessel solely for safety compliance checks or marine sanitation inspections without probable cause or reasonable suspicion of a violation.
  - Rules are applicable for all boats (commercial/residential).
  - Resource checks can still be conducted.
- Trespassing letter to SWFWMD – does this need to be renewed yearly?
  - No. Statutorily the letter would be in effect if the property owner is the same.
- How many tickets have been issued?
  - Approximately 100 in the last month.

## NEW BUSINESS

- Discussion of WAC future
  - Kathryn Birren (KB) attended the BOCC mtg on July 8<sup>th</sup> and addressed the commissioners on her support for the WAC.
  - Maryann Johnson (MJ) supports the WAC and feels it serves an important outlet for citizens to state their concerns regarding our waterways.
  - Ron Zellmer (RZ) also supports the continuation of the WAC as it provides another pair of eyes on our waters.
  - Procedure to remove WAC member for non-participation/attendance.
- Citizens' comments:
  - How would citizens get issues addressed if WAC was disbanded?
    - Citizens could provide comments at a BOCC meeting under citizens comment time.
  - When does the WAC vote on items? How many committee members are needed.
    - A quorum is needed to vote on a motion.
  - How can a citizen report an issue on the water?
    - Contact the Parks office (352-754-4031) or Waterways manager (Carla Burrmann).
  - Can the WAC take concerns/issues to the BOCC?
    - Yes. The WAC can advise the BOCC about any concerns/issues.
  - Can items/tasks be delegated to the WAC from Waterways staff?
    - WAC members' duties are established under section 7-153.

## INFORMATIONAL ITEMS

- Navigational marker repairs – all missing signs have been installed with the exception of those on the Chassahowitzka River. County staff are currently working with Citrus County to locate a suitable location to moor our barge as it will need to be in the area for several days to install the missing poles/signs.
- Spoil Island debris – task completed. The county removed ~5400 lbs. of debris from the islands.

## CITIZENS' COMMENTS

- Were the canals surveyed to identify debris in waters?
  - HCSO conducted a survey and did not locate any debris which would cause a navigation issue.
- What is the status of the canal maintenance study?
  - The county's consultants are currently analyzing the data and will be making a formal presentation at the BOCC meeting in August 2025.
- When will Pine Island open?
  - The county is hoping to have it open by end of July 2025. All structures will be mobile so they can be removed for a storm event.
- How will citizen park at Pine Island?
  - Park mobile app will be used along with two kiosks on-site.
- Is there an update on the Manatee Protection Zone (MPZ)?
  - The draft ordinance is being reviewed by county legal staff. Once completed, the ordinance will be advertised and presented at a BOCC meeting.
- Does the county spray waterbodies for invasive vegetation?
  - No. The county does not spray aquatic vegetation.
- Is the cut-through area from Weeki Wachee River to Mud Lake under an ISNW?
  - Yes. It is currently an Idle Speed No Wake (ISNW) however there are no signs in the cut-through area.
- Citizen located on Cheeks Creek requested to have an ISNW sign moved as it was too close to their dock.
  - Staff will look into this issue and reach out to FWC.
- Is there county staff or an HCSO deputy that can be stationed at Bayport boat ramp to control unruly people?

- Lt. Reak said to contact the HCSO when issues arise. County staff are not present at this boat ramp currently.
- Is the MPZ proposed for year-round enforcement?
  - Yes.
- Is there an update on the Weeki Wachee Preserve Park?
  - The construction plans are at 30% completion and the educational plan is under review by SWFMWD. The county hopes to be under construction within one year.
- What is the status of restoration activities at Jenkins Creek?
  - County staff are working with FWC on proposed restoration activities.
- What happened with the inflatable structure in the flats off Hernando Beach?
  - DEP contacted the owner, and had it removed as it was a violation of state regulations.

## **WATERWAYS ADVISORY COMMITTEE / STAFF COMMENTS**

- A person will be selected to fill the WAC member vacancy and will be chosen at the July 22<sup>nd</sup> BOCC meeting.
- The Aquatic Services & Waterways Department and the Environmentally Sensitive Lands program will be combined in FY26 to create the Natural Resources Department.
