This letter is to inform you as an adjoining property owner that the Hernando County Board of County Commissioners (BOCC) has received a petition from **Clarence and Cindy Bailey within Spring Hill Unit 21 subdivision**. The petitioner is seeking this vacation for the **removal of the Rear and Right-Side Drainage and Utility Easements for**. A copy of the petitioners' survey is enclosed. **BEGIN AT THE NORTHWEST CORNER OF LOT 21, BLOCK 1453, SPRING HILL, UNIT 21, ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 09, PAGES 81 THROUGH 96 OF THE PUBLIC RECORDS OF HERNANDO COUNTY, FLORIDA; THENCE THE FOLLOWING FIVE (5) CALLS: SOUTH 45°21'28" EAST 6.00 FEET; THENCE SOUTH 44°38'32" WEST 115.00 FEET; THENCE SOUTH 45°21'28" EAST 68.00 FEET; THENCE SOUTH 44°38'32" WEST 10.00 FEET; THENCE NORTH 45°21'28" WEST 74.00 FEET TO THE SOUTHWEST CORNER OF SAID LOT 21, BLOCK 1453; THENCE NORTH 44°38'32" EAST 125.00 FEET TO THE POINT OF BEGINNING.**
