

**RESOLUTION NO. 2026-\_\_\_\_\_**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA, AUTHORIZING THE EXECUTION OF PUBLIC TRANSPORTATION GRANT AGREEMENTS WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR STATE BLOCK GRANT (CONTRACT NO. G3O94) AND FEDERAL TRANSIT ADMINISTRATION SECTION 5311 (CONTRACT NO. G3P64) FUNDING FOR HERNANDO COUNTY FOR FISCAL YEAR 2026; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, funds are made available to the Hernando County Board of County Commissioners (“Board”) under the State Block Grant and the Federal Transit Administration (“FTA”) under Section 5311 funding program through the Florida Department of Transportation (“FDOT”); and

**WHEREAS**, the Board will undertake operating activities in accordance with the executed Public Transportation Grant Agreement, which provides for the participation of the FDOT in providing State Block Grant and FTA Section 5311 funding to Hernando County (“County”); and

**WHEREAS**, the State Block Grant funding may be used as part of the matching requirements for FTA Section 5307 (Urbanized Formula Program Grant), which identifies projects and activities necessary for fixed-route mass transit service, and FTA Section 5311 funding will be used for operating expenses.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA AS FOLLOWS:**

**Section 1. Incorporated Whereas Clauses.** The foregoing Whereas clauses are true and correct and are hereby incorporated herein by reference.

**Section 2. Applicability.** This Resolution applies to the following Public Transportation Grant Agreements by and between the Hernando County Board of County Commissioners and the Florida Department of Transportation under the State Block Grant and the Federal Transit Administration Section 5311 as follows:

- a.** Grant Source: State Block Grant
- Contract Number: G3O94
- Project Number(s): 408104-1-84-26
- Total Project Cost: \$1,025,512.00
- Matching Funds: \$512,756.00 each from the FDOT and the Board utilizing the Ninth Cent designated fund

- b. Grant Source:** FTA Section 5311
- Contract Number:** G3P64
- Project Number(s):** 401982-1-84-26 and 401982-2-84-26
- Total Project Cost:** \$1,144,090.00
- Matching Funds:** \$572,045.00 each from the FDOT and the Board utilizing the Ninth Cent designated fund

**Section 3. Approval.** The Hernando County Board of County Commissioners hereby approves and authorizes the execution of the applicable Public Transportation Grant Agreements under the State Block Grant (Contract No. G3O94) and FTA Section 5311 (Contract No. G3P64) for Fiscal Year 2026.

**Section 4. Authorization.** The Chairman of the Hernando County Board of County Commissioners, and/or his or her designee, is authorized to take all actions necessary to ensure the execution and fulfillment of the Public Transportation Grant Agreements described herein.

**Section 5. Effective Date.** This resolution shall take effect immediately upon adoption.
