RECOMMENDATION/REQUIRED ACTION: Approve

Recommend approval:

1. Of Contract 24-931 with Liberty Tire Recycling, LLC (Pittsburgh, PA) to provide a tire disposal services; and
2. To authorize the Office of Procurement Services to execute all supporting documentation.

The estimated fiscal impact is \$80,000 (expenditure) and is within, and will not exceed, the Fiscal Year 2024 Budget. Annual expenditures will not exceed available funding in future fiscal year budgets. Commission District 3.

BACKGROUND SUMMARY: The Office of Procurement Services, in coordination with the Office of Solid Waste, issued Request for Quote 2024-00042 for tire disposal services for used tires that accumulate at the County's Central Landfill Facility, located at 13130 County Landfill Road, Tavares, FL 32778. The solicitation replaces expiring contract 22-911 and provides an initial one-year term with four additional one-year terms available. Staff recommends awarding the contract to Liberty Tire Recycling, LLC. Pricing is consistent with the marketplace.

Last fiscal year's expenditure was \$69,126.
